BAC RESOLUTION RECOMMENDING NEGOTIATED PROCUREMENT IN THE SUPPLY AND DELIVERY OF T-SHIRT UNIFORM FOR THE PARTICIPANTS OF THE HEALTH EMERGENCY MANAGEMENT TRAINING OF THE BOTTOM-UP BUDGETING PROJECT CY 2015 OF THE DEPARTMENT OF HEALTH DUE TO TWO FAILED BIDDINGS

WHEREAS, on June 7, 2018, the Bids and Awards Committee through BAC Res. No. 2018-245 declared Failure of Bidding for the Supply & Delivery of T-shirt Uniform for the participants of the Health Emergency Management Training of the Bottom-Up Budgeting Project CY 2015 of the Dept. of Health. No prospective bidder submitted bid proposal for the said contract;

WHEREAS, on June 20, 2018, the Bids and Awards Committee through BAC Res. No. 2018-271 declared second Failure of Bidding for the Supply & Delivery of T-shirt Uniform for the participants of the Health Emergency Management Training of the Bottom-Up Budgeting Project CY 2015 of the Dept. of Health. No prospective bidder submitted bid proposal for the said contract;

WHEREAS, Section 48 of RA 9184 authorizes the Procuring Entity or his duly authorized representative to resort to alternative method of procurement in order to promote economy and efficiency only in highly exceptional cases whenever justified by the conditions provided in RA 9184;

WHEREAS, Pursuant to Section 53 of RA 9184, Negotiated Procurement is an Alternative Method of Procurement whereby the Procuring Entity can directly negotiate a contract with a technically, legally and financially capable supplier where there has been failure of public bidding for the second time as provided in Section 35 of RA 9184 and IRR;

WHEREAS, resorting to Negotiated Procurement is still subject to the prior approval of the Head of the Procuring Entity;

NOW THEREFORE, on motion of Ms. Alicia D. Torres, duly seconded by all members of the Bids and Awards Committee *BE IT RESOLVED* as it is hereby *RESOLVED*, to recommend Negotiated Procurement in the Supply & Delivery of T-shirt Uniform for the participants of the Health Emergency Management Training of the Bottom-Up Budgeting Project CY 2015 of the Dept. of Health due to two failed biddings.

INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF T-SHIRT UNIFORM FOR THE PARTICIPANTS OF THE HEALTH EMERGENCY MANAGEMENT TRAINING OF THE BOTTOM-UP BUDGETING PROJECT CY 2015 OF THE DEPARTMENT OF HEALTH

The Municipal Government of Binangonan through the Trust Fund intends to apply the sum of One Hundred Twenty Three Thousand Nine Hundred Pesos (P123,900.00) being the Approved Budget for the Contract for the Supply & Delivery of T-shirt Uniform for the participants of the Health Emergency Management Training of the Bottom Up Budgeting Project CY 2015 of the Department of Health. Bids received in excess of the ABC shall be automatically rejected at Bid Opening.

The Municipal Government of Binangonan now invites bids for the Supply & Delivery of T-shirt Uniform for the participants of the Health Emergency Management Training of the Bottom Up Budgeting CY 2015 of the Department of Health. Bidders should have completed, within (2) years from the date of submission and receipt of bids, contracts similar to the projects. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizen/sole proprietorships, partnerships, or organizations with at least sixty (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the Municipality of Binangonan through the BAC Office and inspect the Bidding Documents at the address given below starting June 13, 2018 from 8:00 am to 5:00 pm.

A complete set of Bidding Documents maybe purchased by interested bidders at BAC Office upon payment of a non-refundable fee in the amount stated in the revised IRR of RA. 9184.

Bids must be delivered on or before June 20, 2018 at 01:00 pm. at the Municipality of Binangonan BAC Office. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.1 of the Bidding Documents.

Bids will be opened in the presence of the bidders' representatives who choose to attend at Sangguniang Bayan Session Hall at exactly 02:00 p.m. of June 20, 2018. Late bids shall not be accepted.

The Municipal Government of Binangonan reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
