The Municipal Government of Binangonan, through the 20% MDF intends to apply the sum of Three Hundred Sixty Two Thousand Two Hundred Twenty Three Pesos & 75/100 (P362,223.75) being the Approved Budget for the Contract (ABC) to payments under the contract for the Proposed Construction of Perimeter Fence, Isolation Area, Sitio Bunot, Barangay Lunsad Binangonan Rizal. Bids received in excess of the ABC shall be automatically rejected at bid opening.
