



**INVITATION TO BID FOR THE SITE DEVELOPMENT OF THE PROPOSED
DRUG REHABILITATION CENTER AT BARANGAY LUNSAD
BINANGONAN RIZAL**

The Municipal Government of Binangonan, through the 20% MDF intends to apply the sum of Four Million Pesos (P4,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Site Development of the Proposed Drug Rehabilitation Center at Barangay Lunsad Binangonan Rizal. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Municipal Government of Binangonan now invites bids for the Site Development of the Proposed Drug Rehabilitation Center at Barangay Lunsad Binangonan Rizal including Clearing and Earthmoving, Construction of Perimeter Fence, Driveway, and Installation of Electrical and Water Supply System. Completion of the Works is required 60 calendar days. Bidders should have completed within (10) years from the date of submission and receipt of bids, a contract similar to the projects. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships or organizations with at least sixty (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the Municipality of Binangonan through the BAC Office and inspect the Bidding Documents at the address given below starting March 13, 2020 from 8:00 am to 5:00 pm.

A complete set of Bidding Documents maybe purchased by interested bidders from the BAC Secretariat Office and upon payment of a non-refundable fee for the Bidding Documents in the amount stated in the Revised IRR of R.A. 9184.

The Municipality of Binangonan through the Bids and Awards Committee (BAC) will hold a Pre-Bid Conference on March 23, 2020, 02:00 pm at the Sangguniang Bayan Session Hall of the Municipality of Binangonan which shall be open to all interested parties.

Bids must be delivered on or before April 3, 2020, 10:00 am. at the Municipality of Binangonan BAC Office. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.1 of the Bidding Documents.

Bids will be opened in the presence of the bidder's representatives who choose to attend at Sangguniang Bayan Session Hall at exactly 10:00 am of April 3, 2020. Late bids shall not be accepted.
