

This CONTRACT made and executed by and between:

MUNICIPALITY OF BINANGONAN, RIZAL

A duly organized government institution with seat of government at Barangay Calumpang, Binangonan Rizal represented herein by the Mayor, HON. ENGR. CESAR M. YNARES, Filipino Citizen, of legal age, married with residence and postal address at Barangay Calumpang, Binangonan Rizal, pursuant to Ordinance No. 019, S. 2018 Section 14 dated November 12, 2018 herein referred to as the "MUNICIPALITY".

BASIC ENVIRONMENTAL SYSTEMS AND TECHNOLOGIES, INC

A domestic corporation duly organized and existing under and by virtue of the laws of the Philippines with principal office at Unit 103 G/F Prestige Tower Condominium, F. Ortigas Rd. Ortigas Center, Brgy. San Antonio, Pasig City herein represented by its PRESIDENT, MS. ISABELITA P. MERCADO, hereinafter referred to as the "SECOND PARTY".

WITNESSETH:

Whereas, the FIRST PARTY is mandated under Section 458 (5) (xiii) RA 7160 (xiii) to provide for an efficient and effective system of solid waste and garbage collection and disposal, prohibit littering and the irresponsible placing and throwing of garbage, refuse and other filth and wastes materials. Rule V Article 25 (f) of its IRR further enjoined local government units to provide a "solid waste disposal of environmental management systems and services or facilities related to general hygiene and sanitation".

Whereas, on January 09, 2019, the FIRST PARTY through its Bids and Awards Committee conducted a Public Bidding for the services of a company that operates and manages a sanitary landfill facility compliant to the provisions of RA 9003 and located within the Province of Rizal where the LGU's solid waste residuals are to be disposed;

Whereas, the SECOND PARTY, the lone bidder submitted a single calculated bid which was found responsive, hence by virtue of BAC Resolution No.2019-003 dated January 10, 2019, the Bids and Awards Committee has awarded the contract to the SECOND PARTY in accordance with Government Accounting and Auditing manual;

Whereas, the SECOND PARTY agreed and accepted the award to undertake the project;

NOW THEREFORE, for and in consideration of the foregoing premises and the stipulations and undertaking set forth herein, the parties hereto have agreed as they hereby agree to enter into a contract of SOLID WASTE DISPOSAL SERVICE OF A SANITARY LANDFILL for the Municipality of Binangonan, Rizal under the following terms and conditions.



I. TERMS OF CONTRACT

- 1.1 The term of this contract shall be for 12 months, the period beginning January 28, 2019 ending on December 31, 2019, unless sooner terminated by the FIRST PARTY on justified grounds after due notice and consultation.
- 1.2 Said term may be extended or renewed at the option of the FIRST PARTY and for such period of time provided for under the procurement laws and such other laws, rules and regulations.
- 1.3 It is understood that after the expiration of this contract, the SECOND PARTY shall continue to extend its services until a new bidding is conducted and a contract is awarded.

II. CONTRACT PRICE

- 2.1 In consideration of the services of the SECOND PARTY, the FIRST PARTY undertakes to pay the SECOND PARTY the amount of Three Hundred Pesos (P300.00) per cubic meter of residual waste disposed in the Morong Landfill.

III. OTHER PROVISIONS




