Bidding will be conducted through open competitive bidding procedures using non discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizen/sole proprietorships, partnerships, or organizations with at least sixty (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the Municipality of Binangonan through the BAC Office and inspect the Bidding Documents at the address given below starting September 28, 2022 from 8:00 am to 5:00 pm.

A complete set of Bidding Documents maybe purchased by interested bidders at BAC Office upon payment of a non-refundable fee in the amount of stated in the revised IRR of R.A. 9184.

The Municipality of Binangonan will hold a Pre-Bid Conference on October 06, 2022, 02:00 pm. at Sangguniang Bayan Session Hall of the Municipality of Binangonan which shall be open only to all interested parties who have purchased the Bidding Documents.

Bids must be delivered on or before October 14, 2022 at 02:00 pm. at the Municipality of Binangonan BAC Office. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.1 of the Bidding Documents.

Bids will be opened in the presence of the bidders' representatives who choose to attend at Sangguniang Bayan Session Hall at exactly 02:00 p.m. of October 14, 2022. Late bids shall not be accepted.
